

## **PRIVACY POLICY**

### **Additional information on data protection**

#### **I. Introduction**

Banco Santander, S.A. (hereinafter "the **Bank**"), as the owner and provider of the information service provided on this website [https://santanderinternationalbankingconference.com/] (hereinafter, the "**Portal**"), is fully compliant with regulations governing the protection of personal data and, in particular, with Regulation (EU) 2016/679 of the European Parliament and of the Council, of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter "**GDPR**"), such that any personal information supplied by the party concerned (hereinafter the "**User**") on the Portal shall be processed in compliance with the legally enforceable safeguards and obligations. In accordance with prevailing regulations, the Bank has implemented technical and organisational measures to guarantee an adequate level of security and to prevent the loss, misuse, alteration, unauthorised access or theft of the data provided by the User. The Bank likewise guarantees that it complies with the duty of secrecy and confidentiality in respect of the personal data provided by the User. The communication of personal data by the User is a necessary requirement for them to register for the Event and thus be able to attend it.

#### **IV. Why do we process your personal data and on what legal basis?**

**1. Registering the User for the Event.** The Bank will use the User's data to manage their registration using the registration form to attend the event. The legal basis for this data processing is the execution of a contract.

**2. Managing the User's participation in the Event.** The Bank will use the User's data to manage their participation in the event. The legal basis for this data processing is the execution of a contract.

**3. Sending information about the event via electronic means.** The Bank will use your data to send you information about the event and invite you to its future events. The legal basis for sending the aforementioned communications is the legitimate interests of the Bank.

**4. Sending surveys about the event.** The Bank will send you a survey at the end of the event to find out what you thought about it. Replying is voluntary. The legal basis for sending the aforementioned communications is the legitimate interests of the Bank.

**5. Recording of the event and use of said images on the corporate website santander.com, through social networks and internal channels.** During the celebration of the event, the Bank will proceed to record it for the sole purpose of reproducing and communicating publicly for informative purposes on its website as well as on its social networks. The legitimization of this use is in the Bank's legitimate interest in its capacity as organizer of the event.

#### **IV. How long will we keep your data?**

The personal data provided will be kept for the duration of the event and as long as you do not ask for them to be deleted, in which case they will be blocked for the mandatory period, following which they will be deleted.

#### **V. Will the data be disclosed?**

The User is expressly informed that their personal data shall not be disclosed to third parties, nor shall their data be transferred to third-party countries or international organisations.

#### **VI. What are your rights when you provide us with your data?**

The User may revoke their consent at any time. You may exercise the right to access, rectify or delete your data, and to request that the processing of your personal data be limited, or oppose this, and request the portability of your data, and that it should not be subject to automated individual decisions, by sending an email to [protocolo@gruposantander.com](mailto:protocolo@gruposantander.com) or by writing to Avenida de Cantabria s/n, Ciudad Financiera, Edificio Arrecife Planta 1, 28660, Boadilla del Monte, Madrid, in both cases providing your national ID number or official document proving your identity.
